***RESOLUTION APPROVING RESOLUTION NO. 2023-150 OF THE MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL, ADOPTING AND APPROVING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 23-008, SERIES OF 2023 OF THE SAID MUNICIPALITY***

***WHEREAS***, thereby presented to the Board for review and appropriate action is Resolution No. 2023-150 of the Municipality of Murcia, adopting and approving Municipal Development Council (MDC) Resolution No. 23-008, Series of 2023, entitled: Resolution adopting and approving the proposed programs, projects and activities to be funded out from the 20% Municipal Development Fund (MDF) Calendar Year 2024;

***WHEREAS***, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, after prompt examination by the Provincial Planning and Development Office, it is the recommendation of the said office that the Municipality of Murcia shall indicate in its Annual Investment Program the Typology Codes for climate change adaptation and mitigation programs/projects/activities in compliance with the Joint Memorandum Circular No. 2015-01, known as the Revised Guidelines for Tagging/Tracking Climate Change Expenditures in the Local Budget (Amending JMC 2014-01, dated August 7, 2014), of the Department of the Interior and Local Government;

**WHEREAS**, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same, however, the Municipality of Murcia is recommended to indicate in its Annual Investment Program the Typology Codes for climate change adaptation and mitigation programs/projects/activities;
