RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2023-07 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL, COVERING THE 2023 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID MUNICIPALITY IN THE AMOUNT OF NINE MILLION SEVEN HUNDRED THOUSAND PESOS (P9,700,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2023 General Fund Supplemental Budget No. 6 of the Municipality of Binalbagan, Negros Occidental with a total appropriation of P9,700,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2023-07;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;
