

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 005, SERIES OF 2023 OF THE MUNICIPALITY OF PONTEVEDRA, NEGROS OCCIDENTAL, COVERING THE FY 2023 GENERAL FUND AND ECONOMIC ENTERPRISE MANAGEMENT AND DEVELOPMENT DEPARTMENT SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION FOUR HUNDRED SIXTY TWO THOUSAND PESOS (P2,462,000.00) AND FOUR HUNDRED EIGHTY FIVE THOUSAND PESOS (P485,000.00), RESPECTIVELY

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2023 General Fund and Economic Enterprise Management and Development Department Supplemental Budget No. 4 of the Municipality of Pontevedra, Negros Occidental with a total appropriation of Two Million Four Hundred Sixty Two Thousand Pesos (P2,462,000.00) and Four Hundred Eighty Five Thousand Pesos (P485,000.00), respectively, enacted by the Sangguniang Bayan per Appropriation Ordinance No. 005, Series of 2023;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, CY 2016 Budget Operations Manual for Local Government Units, and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same,

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 005, Series of 2023 of the Municipality of Pontevedra, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code, and further subject to the following conditions:

1. The grant of Gratuity Pay to Contract of Service and Job Order workers for FY 2023 shall be in accordance with the guidelines provided under Budget Circular No. 2023-3 dated December 14, 2023 of the Department of Budget and Management;
2. The disbursement of the appropriation for the Service Recognition Incentive (SRI) shall be made in accordance with the guidelines on the grant of SRI to government employees for FY 2023 provided under Budget Circular No. 2023-2 dated December 13, 2023 of the Department of Budget and Management.
3. The Secretary to the Sanggunian is reminded of Section 56 of the Local Government Code of 1991 which provides that: within three (3) days after approval, the secretary to the sanggunian panlungsod or sangguniang bayan shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
