**RESOLUTION DECLARING ORDINANCE NO. 686, SERIES OF 2023 OF THE CITY OF TALISAY REGULATING THE USE AND OPERATION OF VIDEOKE/KARAOKE MACHINES AND OTHER SIMILAR AMPLIFIED AUDIO DEVICES/SYSTEM WITHIN THE RESIDENTIAL AREAS AND PUBLIC STREETS IN THE CITY OF TALISAY, NEGROS OCCIDENTAL AND PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES, AS A VALID ENACTED ORDINANCE**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, Ordinance No. 686, series of 2023 of the City of Talisay regulating the use and operation of videoke/karaoke machines and other similar amplified audio devices/system within the residential areas and public streets in the City of Talisay, Negros Occidental and providing penalties for violation thereof and for other purposes, was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the subject ordinance, is in line with the Local Government Code, to wit:

*Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.*

*Section. 458. - Powers, Duties, Functions and Compensation. - (a) The Sanggunia Panlungsod, as the legislative body of the city, shall enact ordinances, appr resolutions and appropriate funds for the general welfare of the city and its inhabitt pursuant to Section 16 of this Code and in the proper exercise of the corporate powe the city as provided for under Section 22 of this Code, and shall:*

*(1) Approve ordinances and pass resolutions necessary for an efficient and effective city government, and in this connection, shall:*

*(ii) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, riot, violence, rebellion or sedition and impose penalties for the violation of said ordinances;*

**WHEREAS**, the ordinance finds legal support from the Civil Code", to wit:

*Art. 19. Every person must, in the exercise of his rights and in the performance of his duties, act with justice, give everyone his due, and observe honesty and good faith.*

*Art. 26. Every person shall respect the dignity, personality, privacy and peace of mind of his neighbors and other persons. Xx*

**WHEREAS**, the Sangguniang Panlungsod of the City of Talisay is respectfully reminded of the provision stated under Section 511 of RA 7160 which provides that:

*Section. 458. - Posting and Publication of ordinances with Penal Sanction. - (a) ordinances with penal sanctions shall be posted at prominent places in the provincial capitol, city, municipal and barangay hall, as the case may be got a minimum period of three (3) consecutive weeks. Such ordinances shall also be published in a newspaper of general circulation, where available, within the territorial jurisdiction of the local government unit concerned, except in the case of barangay ordinances. Unless otherwise provided thereon, said ordinances shall take effect on the day following its publication, or at the end of the period of posting, whichever occurs later.*

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. duly seconded by all the members present, during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:
