***RESOLUTION DECLARING ORDINANCE NO. 688, SERIES OF 2023 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, INTEGRATING BARANGAY CLEARANCE FOR PERMITS RELATED TO DOING BUSINESS APPLIED, ISSUED AND COLLECTED IN THE CITY OF TALISAY, NEGROS OCCIDENTAL AND AUTHORIZING THE REMITTANCE OF SUCH COLLECTIONS TO THE RESPECTIVE BARANGAYS, PURSUANT TO REPUBLIC ACT NO. 11032 ENTITLED: "AN ACT PROMOTING EASE OF DOING BUSINESS AND EFFICIENT DELIVERY OF GOVERNMENT SERVICES, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9485, OTHERWISE KNOWN AS THE ANTI-RED TAPE ACT OF 2007, AND FOR OTHER PURPOSES" AS A VALID ENACTED ORDINANCE***

***WHEREAS***, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, subject ordinance, is in line with the Local Government Code, to wit:

*Section. 458. - Powers, Duties, Functions and Compensation. – provides among others that the sangguniang panlungsod as the legislative body of the city, has the power to exercise such other powers and perform such other duties and functions as may be prescribed by law.*

**WHEREAS**, subject ordinance also finds legal support from Circular No. 2019-177 issued by Department of Interior and Local Government (DILG) pursuant to R.A. No. 11032 better known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018" as well as Joint Memorandum Circular No. 2019-001 of CSC, ARTA, and DTI;

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. unanimously seconded by all the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to pass and approve this resolution to wit:
