

RESOLUTION DECLARING ORDINANCE NO. 702, SERIES OF 2023 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, ADOPTING AND IMPLEMENTING THE PALENG-QR PH PROGRAM IN THE CITY OF TALISAY, NEGROS OCCIDENTAL AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 702, Series of 2023 of the City of Talisay, Negros Occidental, entitled: "***AN ORDINANCE ADOPTING AND IMPLEMENTING THE PALENG-QR PH PROGRAM IN THE CITY OF TALISAY, NEGROS OCCIDENTAL***" was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, subject ordinance is rooted in the Department of Interior and Local Government (DILG) and Bangko Sentral ng Pilipinas (BSP) Joint Memorandum Circular No. 01, Series of 2022, dated June 22, 2022. This circular enjoins the active participation of Local Government Units (LGUs) in the Paleng-QR PH Program;

WHEREAS, Section 458 of R.A. No. 7160, also known as the Local Government Code of 1991, stipulates, among other things, that "The sangguniang panlungsod as the legislative body of the city, shall enact ordinances, approve resolutions, and appropriate funds for the general welfare of the city and its inhabitants," pursuant to Section 16 of the Code;

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

NOW THEREFORE, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. unanimously seconded by all members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to pass and approve this resolution to wit:
