**RESOLUTION NO. 0135**

**RESOLUTION DECLARING ORDINANCE NO. 701, SERIES OF 2023 OF THE CITY OF TALISAY AMENDING SECTION 2 OF ORDINANCE NO. 422, SERIES OF 2012 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, AS A VALID ENACTED ORDINANCE**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, Ordinance No. 701, series of 2023 of the City of Talisay amending Section 2 of Ordinance No. 422, series of 2012 of the City of Talisay, Negros Occidental was submitted for review by the City of Talisay to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the subject ordinance finds support from the Local Government Code of 1991 (R.A. 7160), Section 458 (a) (3) (v), to wit:

*Sec. 458. (a) The sangguniang panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code.*

**WHEREAS**, the amendment of an ordinance follows the established principle in local legislation, allowing the authority to enact ordinances to include the power to modify or repeal, ensuring vested rights are unaffected. This authority was emphasized in a ruling, asserting that the sanggunian's power to enact ordinances inherently includes the power to amend them. Amendatory ordinances, as per the subject ordinance, must adhere to specific procedures and directly pertain to the ordinance they seek to modify or revoke. In this case, the amendment to Section 2 of Ordinance No. 422, allocating an annual fund of PhP250,000.00, falls within the jurisdiction of the concerned sanggunian.

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. duly seconded by all the members present, during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:

**RESOLUTION DECLARING ORDINANCE NO. 701, SERIES OF 2023 OF THE CITY OF TALISAY AMENDING SECTION 2 OF ORDINANCE NO. 422, SERIES OF 2012 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL, AS A VALID ENACTED ORDINANCE.**
