**RESOLUTION DECLARING ORDINANCE NO. 700, SERIES OF 2023 OF THE CITY OF TALISAY DECLARING THE MONTH OF OCTOBER AS COOPERATIVE MONTH IN THE CITY OF TALISAY, NEGROS OCCIDENTAL AS A VALID ENACTED ORDINANCE**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, City Ordinance No. 700, series of 2023 of the City of Talisay entitled: “An Ordinance declaring the month of October as Cooperative Month in the City of Talisay, Negros Occidental,” was submitted for review by the City of Talisay, Negros Occidental to the Sangguniang Panlalawigan of Negros Occidental;”

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Talisay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the subject ordinance, is in keeping with the R.A. 9520 (Philippine Cooperative Code of 2008), to wit:

*"It is the declared policy of the State to foster the creation and growth of cooperatives as a practical vehicle for promoting self-reliance*

**WHEREAS**, the ordinance finds legal support from Section 2 of R.A. 11502, "An Act Declaring the Month of October of Every Year as "The National Cooperative Month", to wit:

*"Sec. 2. The Cooperative Development Authority, in consultation with and in partnership with the cooperative development councils, cooperatives development officers, national and local federations and union of cooperatives, and other agencies of the government, shall conduct activities and programs that promote the principles and values of cooperatives and encourage cooperative movement."*

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**WHEREAS**, in view of the foregoing, the SP Committee on Laws recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., and unanimously seconded by all members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve this resolution to wit:
