RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE PHILIPPINE INSTITUTE OF CHEMICAL ENGINEERS NEGROS OCCIDENTAL CHAPTER (PICHE-NOC) RELATIVE TO THE ENVIRONMENTAL IMPACT ASSESSMENT (EIA) NEGROS OCCIDENTAL BULK WATER SUPPLY PROJECT (BULK WATER PROJECT)

WHEREAS, the request of Gov. Eugenio Jose “Bong” Lacson dated January 8, 2024, was endorsed to the Sangguniang Panlalawigan relative to the aforementioned request for the approval and authority to sign the Memorandum of Agreement to be entered into between the Province of Negros Occidental and the Philippine Institution of Chemical Engineers Negros Occidental (PICHE-NOC)",

DENR Administrative Order No. 2001-09 dated January 16, 2001 Section 17, (b) (3) (vii). Basic Services - a project proponent shall be responsible for the payment of all costs related to the review of the EIS/EPRMP in accordance with the guidelines provided by DAO 2003-30 and its procedural manual.

DENR Administrative Order No. 2003-30- such costs shall be placed in and EIA Review Support Fund to be handled by the Fund Manager in order to achieve greater transparency and objectivity of the EIA review process

WHEREFORE, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present;
