RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 23-04 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, COVERING THE 2023 SUPPLEMENTAL BUDGET NO. 3 OF THE SAID CITY IN THE AMOUNT OF FIFTEEN MILLION ONE HUNDRED EIGHTY THOUSAND PESOS (P15,180,000.00) FOR THE GENERAL FUND AND FOUR MILLION THREE HUNDRED FORTY THOUSAND PESOS (4,340,000.00) FOR THE SPECIAL ACCOUNTS (CITY HOSPITAL, CITY WATERWORKS DEPARTMENT, PUBLIC MARKET AND SLAUGHTERHOUSE DEPARTMENT AND THE PUBLIC TRANSPORT TERMINAL DIVISION)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2023 Supplemental Budget No. 3 of the City of San Carlos, Negros Occidental with a total appropriation of P15,180,000.00 for the General Fund and P4,340,000.00 for the Special Accounts (City Hospital, City Waterworks Department, Public Market and Slaughterhouse Department and the Public Transport Terminal Division), enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 23-04;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 23-04 of the City of San Carlos covering the 2023 Supplemental Budget No. 3 of the said city with a total appropriation of P15,180,000.00 for the General Fund and P4,340,000.00 for the Special Accounts (City Hospital, City Waterworks Department, Public Market and Slaughterhouse Department and the Public Transport Terminal Division) subject to the condition that the grant of Service Recognition Incentive (SRI) to government employees for 2023 shall be in accordance with Administrative Order No. 12, series of 2023 dated December 7, 2023 and implementing guidelines under Budget Circular No. 2023-2 dated December 13, 2023 of the DBM.

RESOLVED FINALLY, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

This resolution shall take effect immediately upon approval.
