RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 12, SERIES OF 2023 OF THE CITY OF SILAY, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY-EIGHT MILLION FIVE HUNDRED THIRTY-NINE THOUSAND FIVE HUNDRED FIFTY-THREE PESOS AND SIXTY-TWO CENTAVOS (P28,539,553.62) FOR THE SUPPLEMENTAL BUDGET NO. 11 OF THE GENERAL FUND OF THE CITY OF SILAY FOR CALENDAR YEAR 2023”

WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 12, Series of 2023 of the City of Silay, Negros Occidental entitled: “AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY-EIGHT MILLION FIVE HUNDRED THIRTY-NINE THOUSAND FIVE HUNDRED FIFTY-THREE PESOS AND SIXTY-TWO CENTAVOS (P28,539,553.62) FOR THE SUPPLEMENTAL BUDGET NO. 11 OF THE GENERAL FUND OF THE CITY OF SILAY FOR CALENDAR YEAR 2023”;

WHEREAS, said Appropriation Ordinance is therefore recommended for approval and considered operative as of the date of its stated effectivity subject to the following conditions;

1. The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with RA 10121 and its implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
2. The Gender and Development (GAD) Plan and Budget shall be prepared pursuant to RA No. 7192, RA No. 9710 and Philippine Commission on Women-DILG-DBM-NEDA JMC No. 2016-01 dated January 12, 2016 and that the same shall be reviewed and endorsed by the DILG;
3. The grant of the Service Recognition Incentive (SRI) for FY 2023 shall be in accordance with the provisions of Budget Circular No. 2023-02 dated December 13, 2023 of the Department of Budget and Management; and
4. The local government unit must indicate the proper AIP reference codes under column three (3) of Local Budget Preparation Form No. 9. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

WHEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 12, Series of 2023 of the City of Silay, Negros Occidental entitled: "AN ORDINANCE APPROPRIATING THE AMOUNT OF TWENTY-EIGHT MILLION FIVE HUNDRED THIRTY-NINE THOUSAND FIVE HUNDRED FIFTY-THREE PESOS AND SIXTY-TWO CENTAVOS (P28,539,553.62) FOR THE SUPPLEMENTAL BUDGET NO. 11 OF THE GENERAL FUND OF THE CITY OF SILAY FOR CALENDAR YEAR 2023";
