**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2023 OF THE MUNICIPALITY OF MURCIA, NEGROS OCCIDENTAL, COVERING THE 2023 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID MUNICIPALITY IN THE AMOUNT OF EIGHT MILLION SIX HUNDRED ONE THOUSAND PESOS (P8,601,000.00)**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2023 General Fund Supplemental Budget No. 2 of the Municipality of Murcia, Negros Occidental with a total appropriation of P8,601,000.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 03, series of 2023;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

**WHEREAS**, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 03, series of 2023 of the Municipality of Murcia covering the 2023 General Fund Supplemental Budget No. 2 of the said municipality with a total appropriation of P8,601,000.00 subject to the condition that the grant of Collective Negotiation Agreement (CNA) Incentive shall be in accordance with the provisions of Budget Circular No. 2023-1 dated November 10, 2023 of the DBM, with emphasis on Sections 4.1.1 and 4.1.2(d);

**RESOLVED FURTHER**, that the Local Government Unit must indicate the proper AIP reference codes under column three (3) of LBPF No. 9. The AIP reference code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

**RESOLVED FINALLY**, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
