RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 4, SERIES OF 2023 OF THE CITY OF TALISAY, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY-FOUR MILLION FIVE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS AND 63/100 (P64,570,734.63) FOR THE ADDITIONAL APPROPRIATION TO THE NEWLY IDENTIFIED PROGRAMS AND PROJECTS IN THE CITY, AND FOR THE GRANT OF PERFORMANCE BASED BONUS AND OTHER PERSONNEL BENEFITS OF THE CITY OFFICIALS AND EMPLOYEES OF THE CITY OF TALISAY, NEGROS OCCIDENTAL”

WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 4, Series of 2023 of the City of Talisay, Negros Occidental entitled: “AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY-FOUR MILLION FIVE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS AND 63/100 (P64,570,734.63) FOR THE ADDITIONAL APPROPRIATION TO THE NEWLY IDENTIFIED PROGRAMS AND PROJECTS IN THE CITY, AND FOR THE GRANT OF PERFORMANCE BASED BONUS AND OTHER PERSONNEL BENEFITS OF THE CITY OFFICIALS AND EMPLOYEES OF THE CITY OF TALISAY, NEGROS OCCIDENTAL”;

WHEREAS, the pre-review shows apparent compliance with the same law, its Implementing Rules and Regulations, CY 2016 Budget Operations Manual for Local Government Units and implementing circulars and other issuances. **However, the City is encouraged to observe the timeline on the submission of the Appropriation Ordinance**

to the reviewing authority pursuant to Section 56(a) of RA 7160, which states that: **“Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan – (a) Within three (3) days after approval, the secretary to the Sanggunian Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils”;**

WHEREAS, said Appropriation Ordinance is therefore recommended for approval and considered operative as of the date of its stated effectivity subject to the following conditions:

1. The disbursement of the appropriation for Other Personnel Benefits (OPB) shall strictly be in accordance with the existing laws/issuances on compensation and benefits;
2. The grant of Performance Based Bonus (PBB) for FY 2022 shall be subject to DILG-DBM Joint Memorandum Circular No. 2021-01, dated November 22, 2021 of the Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems;
3. The disbursement of Donations shall be used solely for public purposes and subject to Section 36 and 305(b) of the Local Government Code of 1991; and
4. The utilization of Local Disaster Risk Reduction and Management fund shall be in accordance with RA 10121 and its implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013.

WHEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 4, Series of 2023 of the City of Talisay, Negros Occidental entitled: **“AN ORDINANCE APPROPRIATING THE AMOUNT OF SIXTY-FOUR MILLION FIVE HUNDRED SEVENTY THOUSAND SEVEN HUNDRED THIRTY-FOUR PESOS AND 63/100 (P64,570,734.63) FOR THE ADDITIONAL APPROPRIATION TO THE NEWLY IDENTIFIED PROGRAMS AND PROJECTS IN THE CITY, AND FOR THE GRANT OF PERFORMANCE BASED BONUS AND OTHER PERSONNEL BENEFITS OF THE CITY OFFICIALS AND EMPLOYEES OF THE CITY OF TALISAY, NEGROS OCCIDENTAL”;**

FURTHER RESOLVED, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.
