RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2023-05 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 5, FY 2023 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL” AMOUNTING TO TWENTY THREE MILLION SIX HUNDRED THIRTY FIVE THOUSAND PESOS (P23,635,000.00)

WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 2023-05 of the City of Himamaylan, Negros Occidental entitled: “AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 5, FY 2023 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL” AMOUNTING TO TWENTY THREE MILLION SIX HUNDRED THIRTY FIVE THOUSAND PESOS (P23,635,000.00);

WHEREAS, the pre-review shows apparent compliance with the same law, its Implementing Rules and Regulations, CY 2016 Budget Operations Manual for Local Government Units and implementing circulars and other issuances;

WHEREAS, said Appropriation Ordinance is therefore recommended for approval and considered operative as of the date of its stated effectivity subject to the following conditions:

1. Strict adherence in the period as to the submission of Appropriation Ordinances to the Sanggunian Panlalawigan for review per Section 56(a) of RA 7160, which states that:”Review of

Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan –
(a) Within three (3) days after approval, the secretary to the Sanggunian Palungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils;

1. The grant of CNA Incentive shall be in accordance with the provisions of Budget Circular No. 2023-1, emphasis on Section 4.1.1 and 4.1.2(d), dated November 20, 2023 of the Department of Budget and Management;
2. The grant of the Service Recognition Incentive (SRI) for FY 2023 shall be in accordance with the provisions of Budget Circular No. 2023-02 dated December 13, 2023 of the Department of Budget and Management;
3. The grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) Workers shall be in accordance with Budget Circular NO. 2023-3 dated December 14, 2023 of the Department of Budget and Management; and
4. The local government unit must indicate the proper AIP reference codes under column three (3) of Local Budget Preparation Form No. 9. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

WHEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2023-05 of the City of Himamaylan, Negros Occidental entitled: “AN ORDINANCE APPROVING SUPPLEMENTAL BUDGET NO. 5, FY 2023 OF THE CITY OF HIMAMAYLAN, NEGROS OCCIDENTAL” AMOUNTING TO TWENTY THREE MILLION SIX HUNDRED THIRTY FIVE THOUSAND PESOS (P23,635,000.00);

FURTHER RESOLVED, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the city government.
