
WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2023-229 of the City of Himamaylan approving Resolution No. 04-2023 of the LDRRMC, approving the priority programs/projects/activities to be funded by the 5% LDRRMF CY 2024 in the amount of P54,744,430.00;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is in line with the mandate of R.A. 7160, otherwise known as the Local Government Code of 1991 which provides for local government units to formulate their 20% development programs/projects based on their respective thrusts/priorities as part of their planning, programming, budgeting system and as a mechanism to implement their local development plans;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;
