

RESOLUTION DECLARING CITY ORDINANCE NO. 2023-004 OF THE CITY OF KABANKALAN INSTITUTIONALIZING THE ANNUAL CELEBRATION OF THE KABANKALAN CITY BIBLE MONTH EVERY JANUARY AND BIBLE SUNDAY EVERY LAST SUNDAY THEREOF, CREATING A STEERING COMMITTEE, PROVIDING FUNDS THEREFOR AND FOR OTHER PURPOSES. AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, City Ordinance No. 2023-004 of the City of Kabankalan institutionalizing the annual celebration of the Kabankalan City Bible Month every January and Bible Sunday every last Sunday thereof, creating a steering committee, providing funds therefor and for other purposes was submitted for review by the City of Kabankalan to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Kabankalan to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;
