RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2023-011 OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL, AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 18-003 BY INCREASING THE TRICYCLE FARE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ILOG AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Bayan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Municipal Ordinance No. 2023-011 of the Municipality of Ilog, Negros Occidental, entitled: "***AN ORDINANCE AMENDING SECTION 1 OF MUNICIPAL ORDINANCE NO. 18-003 BY INCREASING THE TRICYCLE FARE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ILOG***" was submitted for review by the Municipality of Ilog to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of Ilog enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, the validity of the subject ordinance is based on Section 447 of R.A. No. 7160, commonly known as the Local Government Code of 1991, specifically paragraph 3(vi), which grants the Sangguniang Bayan authority, as the municipality's legislative body, to issue franchises and regulate tricycle operations, subject to guidelines set by the Department of Transportation as outlined in Book II of the said Code;

WHEREAS, Land Transportation Office Memorandum No. 94-199 issued on May 2, 1994, grants the Sangguniang Bayan of Ilog the authority to establish, set, specify, or periodically revise fares or rates for services within a designated zone following a public hearing;

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

NOW THEREFORE, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. unanimously seconded by all the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to pass and approve this resolution to wit:
