RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2023-14 OF THE MUNICIPALITY OF CALATRAVA CREATING THE POSITIONS OF ADMINISTRATIVE ASSISTANT I (REPRODUCTION MACHINE OPERATOR III) SG 7 AND LOCAL LEGISLATIVE STAFF EMPLOYEE II, SG 4 IN THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG BAYAN

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2023-14 of the Municipality of Calatrava creating the positions of Administrative Assistant I (Reproduction Machine Operator III) SG 7 and Local Legislative Staff Employee II, SG 4 in the Office of the Secretary to the Sangguniang Bayan;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the powers of the Sangguniang Bayan of Calatrava to enact pursuant to Section 447(a)(1)(viii) of RA 7160, otherwise known as the Local Government Code of 1991 and within the Personal Services limitation set under Section 235(a) thereof;
