WHEREAS, thereby presented to the Board for appropriate action is Municipal Ordinance No. 2023-16 of the Municipality of Calatrava, Negros Occidental entitled: “AN ORDINANCE CREATING THE POSITIONS OF LOCAL TREASURY OPERATIONS OFFICER II SG 15, LOCAL TREASURY OPERATION ASSISTANT SG 8, REVENUE COLLECTION CLERK II SG 7, ADMINISTRATIVE AIDE IV (REPRODUCTION MACHINE OPERATOR II) SG 4, TWO (2) TICKET CHECKER SG 3 IN THE MUNICIPAL TREASURER’S OFFICE”;

WHEREAS, the subject ordinances are certainly anchored on the scattered provisions of Section 447 of RA No. 7160 otherwise known as the Local Government Code of 1991 which provide among others that the sangguniang bayan as the legislative body of the municipality, has the power to enact ordinances for the general welfare of its inhabitants specifically, the said sanggunian is mandated to **DETERMINE POSITIONS, SALARIES, WAGES, ALLOWANCES, and other emoluments and benefits of officials and employees;**

WHEREAS, section 325 of the Code explicitly states in this instance that the use of municipal funds shall be subject to certain limitations while it is mandated under section 76 and 78 thereof that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission and other issuances promulgated pursuant thereto like the herein mentioned IOS-LGU 2021;

WHEREAS, the same may be given due course subject to the Index of Occupational Services, Position Titles, and Salary Grades in the Local Government Units (IOS-LGUs);

WHEREFORE, on motion of Hon. Manuel Frederick O. Ko, unanimously seconded by all the members present;
