**WHEREAS**, in the case of a consultant for new hiring, it is imperative that the credentials containing academic or educational achievements as well as experiential services must be submitted for added information, and in the case of the renewal consultant, the performance output or report must also be submitted in written form, mentioning important or significant contributions as well as the enumeration of modern-day ideas for the improvement of services of a given project or proposal, and other materials or relevant contribution will also be submitted as may be deemed necessary;

**WHEREAS**, this procedure is hereby established for the purpose of maintain well-defined consultancy services with regards to signing of as a prior requisite for the signing of the Memorandum of Consultancy Services;

**WHEREAS**, the Consultancy Services will give positive results that will further expected yield results that are beneficial for satisfaction of public services as well as management of public budgets or programs for the benefits of the people of the Province of Negros Occidental;

**NOW, THEREFORE**, for premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon duly seconded by Hon. Manuel Frederick O. Ko during the regular session of the Sangguniang Panlalawigan of Negros Occidental,
