RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL TREASURER TO CHARGE AGAINST THE CURRENT BUDGET UNDER THE 2024 SPECIAL PURPOSE APPROPRIATIONS – TERMINAL LEAVE ACCOUNT THE UNPAID TERMINAL LEAVE PAY OF THE VARIOUS PROVINCIAL GOVERNMENT EMPLOYEES IN THE TOTAL AMOUNT OF FIVE HUNDRED SIX THOUSAND THREE HUNDRED FORTY EIGHT PESOS AND SIXTY FOUR CENTAVOS (P506,348.64)
