RESOLUTION ADOPTING EXECUTIVE ORDER NO. 24-09, SERIES OF 2024 ENTITLED: "AN ORDER DECLARING EVERY THIRD WEEK OF THE MONTH OF MAY AS PROVINCIAL RENEWABLE ENERGY (RE) WEEK IN THE PROVINCE OF NEGROS OCCIDENTAL"

WHEREAS, thereby presented for review and appropriate action of the Board is the request for the passage of a resolution adopting Executive order No. 24-09, series of 2024 entitled: "An Order Declaring every third week of the month of May as Provincial Renewable Energy (RE) Week in the Province of Negros Occidental;

WHEREAS, the subject executive order is consistent with Section 465 (2)(b)(iii) of RA 7160, which provides:

Section 465. The Chief Executive: Powers, Duties, Functions and Compensation.

(a) The provincial governor, as the chief executive of the provincial government, shall exercise such powers and perform such duties and functions as provided by this Code and other laws;

(b) For efficient, effective and economical governance the purpose of which is the general welfare of the province and its inhabitants pursuant to Section 16 of this Code, the provincial governor shall:
