ORDINANCE NO. 003
Series of 2024

AN ORDINANCE RENAMING THE OFFICE OF THE GOVERNOR-DISASTER MANAGEMENT PROGRAM DIVISION TO OFFICE OF THE GOVERNOR-PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (PDRRMO)

WHEREAS, the Philippine Disaster Risk Reduction and Management (PDRRM) Act of 2010 mandates the establishment of LDRRMOs in provinces, cities and municipalities and BDRRMC's in barangays;

WHEREAS, Section 12 of RA 10121 (Philippine Disaster Risk Reduction and Management Act of 2010) provides that:

- a. There shall be established an LDRRMO in every province, city and municipality and a Barangay Disaster Risk Reduction and Management Committee (BDRRMC) in every barangay which shall be responsible for setting the direction, development, implementation and coordination of disaster risk management programs within their territorial jurisdiction.
- b. The LDRRMO shall be under the Office of the Governor, City or Municipal Mayor, and the Punong Barangay in case of the BDRRMC. The LDRRMOs shall be initially organized and composed of a DRRMO to be assisted by three (3) staff responsible for: (1) administration and training, (2) research and planning; and (3) staff operations and warning. The LDRRMOs and the BDRRMCs shall organize, train and directly supervise the local emergency response teams and the ACDVs.

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC), DILG, DBM and CSC issued Joint Memorandum Circular No. 2014-1 dated April 14, 2014 which provides the Implementing guidelines in the establishment of Local DRRM Offices (LDRRMOs) of the Barangay DRRM Committees (BDRRMCs) in the local government units;

NOW THEREFORE, be it enacted by the Sangguniang Panlalawigan of Negros Occidental in its Regular Session duly assembled that:

SECTION 1. RENAMING THE OFFICE OF THE GOVERNOR-DISASTER MANAGEMENT PROGRAM DIVISION TO OFFICE OF THE GOVERNOR-PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (PDRRMO). The Office of the Governor - Disaster Management Program Division is hereby renamed to Office of the Governor - Provincial Disaster Risk Reduction Management Office (PDRRMO) to adhere with the existing provisions mandated by RA 10121 and in accordance with the JMC No. 2014-1.

SECTION 2. SEPARABILITY CLAUSE. – If for any reason, any provision, section or part of this ordinance is declared not valid by a government agency or a court of competent jurisdiction, such judgment shall not affect the other sections or provisions of this ordinance, which shall continue to be in full force and effect.

SECTION 3. REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 4. EFFECTIVITY. – This Ordinance shall take effect immediately upon approval.
