RESOLUTION APPROVING THE DEED OF DONATION TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL RELATIVE TO THE DONATION OF TORPEDO BUOY, RESCUE LIFE VEST, SPINE BOARD AND PADDED BOARD SPLINT KIT IN FAVOR OF THE SAID MUNICIPALITY

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the Deed of Donation to be entered into by and between the Province of Negros Occidental and the Municipality of Binalbagan, Negros Occidental relative to the donation in favor of the latter, to wit:

- Two (2) units Torpedo Buoy (specifically described in the deed) with a total of Seven Thousand Twenty Pesos (P7,020.00).*
- Six (6) units Rescue Life Vest (specifically described in the deed) with a total amount of Fifteen Thousand Three Hundred Ninety Pesos (15,390.00).*
- One (1) unit Spine Board (specifically described in the deed) amounting to Six Thousand Six Hundred Thirty Pesos (P6,630.00).*
- Two (2) units Padded Board Splint Kit (specifically described in the deed) with a total amount of Eleven Thousand Three Hundred Thirty Pesos (P11,330.00).*

WHEREAS, the Deed of Donation is in order and conforms to the requirements on the law of contracts;

WHEREAS, the SP Committee on Laws favorably endorsed the passing of the same;
