RESOLUTION DECLARING ORDINANCE NO. 021, SERIES OF 2024 OF THE MUNICIPALITY OF LA CASTELLANA ENTITLED: "AN ORDINANCE DECLARING THE LAST WEEK OF OCTOBER 2024 AND EVERY YEAR THEREAFTER AS MUNICIPALITY CORRECTIONAL CONSCIOUSNESS WEEK IN THE MUNICIPALITY OF LA CASTELLANA", AS A VALID ENACTED ORDINANCE

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

WHEREAS, Ordinance No. 021, series of 2024 of the Municipality of La Castellana declaring the last week of October 2024 and every year thereafter as Municipality Correctional Consciousness Week in the Municipality of La Castellana"; was submitted for review by the Municipality of La Castellana to the Sangguniang Panlalawigan of Negros Occidental;

WHEREAS, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of La Castellana to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

WHEREAS, The legal foundation for Ordinance No. 021 of the Municipality of La Castellana stems from Section 447(a)(5)(xv) of the Code, which grants the Sangguniang Bayan the authority to endorse ordinances for the establishment, upkeep, and enhancement of jails and detention centers. This includes implementing effective jail management programs and allocating funds for the support of detainees and convicted individuals within the municipality. Additionally, it draws support from Presidential Proclamation No. 551 issued on March 15, 1995;

WHEREAS, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

NOW THEREFORE, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. unanimously seconded by all the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:
