***RESOLUTION ADOPTING THE TEN-YEAR PROVINCIAL SOLID WASTE MANAGEMENT PLAN OF THE PROVINCE OF NEGROS OCCIDENTAL PURSUANT TO REPUBLIC ACT 9003 OR THE ECOLOGICAL SOLID WASTE MANAGEMENT ACT OF 2000***

***WHEREAS***, it is the policy of the state to adopt a systematic, comprehensive and ecological solid waste management program which shall ensure the protection of public health and environment;

***WHEREAS***, it is the priority of the Province of Negros Occidental to protect human health and the environment through safe and effective management of solid waste;

***WHEREAS***, Executive Order No. 23-14, Series of 2023, created the Provincial Solid Waste Management Board (PSWMB) in accordance with Republic Act No. 9003, also known as the Ecological Solid Waste Act of 2000;

***WHEREAS***, it is the responsibility of the Provincial Solid Waste Management Board to develop a Provincial Solid Waste Management Plan consolidating the submitted solid waste management plan of its component cities and municipalities;

***WHEREAS***, the Ten-Year Provincial Solid Waste Management Plan (2022-2032) is a consolidation of the respective plans of all component local government units that shall serve to guide all policies and actions towards the accomplishment of our vision and mission for solid waste management;
