**RESOLUTION COMMENDING PBGEN. SIDNEY N. VILLAFLORE FOR HIS SERVICE AND DEDICATION DURING HIS TOUR OF DUTY AS REGIONAL DIRECTOR OF PHILIPPINE NATIONAL POLICE - REGIONAL OFFICE VI (PNP-ROVI)**

**WHEREAS**, during PBGen. Villaflore's term as PNP Regional Director of Police Regional Office (PRO) 6 from May 24, 2023 up to February 15, 2024 he strictly directed the Negros Occidental PPO personnel under the leadership of its Provincial Director to conduct series of massive Anti-Illegal Drug Operations which resulted to the Confiscation and Recovery of Very Significant Volume of Illegal Drugs more particularly Shabu and the arrest and filing of criminal charges against numerous High Value Individuals (HVIs) & Street Level Individuals (SLIs) Target Personalities who were peddling Illegal Drugs;

**WHEREAS**, under his leadership, the PRO-VI Drug Underground Shipment and Transport Network Disruption (DUST Bin) integration emerged as a key strategy in combating illegal drugs, significantly boosting the efficacy of intervention efforts;

**WHEREAS**, the above-approach has been adopted by the PNP organization and stands as one of PRO-6's exemplary practice in its drug enforcement campaign;

**WHEREAS**, PBGen. Villaflore also initiated the drafting of a Regional Law Enforcement Coordination Committee (RLECC) Resolution advocating for the active participation of member agencies in interdicting illicit drugs at seaports and airports that represented a historic achievement for PRO-VI, distinguishing it as the "first" Police Regional Office to introduce such a resolution nationwide;
