**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-01, OF THE CITY OF ESCALANTE, NEGROS OCCIDENTAL APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 1 OF THE SAID CITY IN THE AMOUNT OF FOUR MILLION SIX HUNDRED FIFTY THREE THOUSAND FOUR HUNDRED SEVENTY ONE PESOS (P4,653,471.00)**
