WHEREAS, thereby presented to the Board for review and appropriate action is Resolution No. 24-074 of the City of Bago, approving Resolution No. 03, Series of 2024 of the City Development Council Executive Committee, entitled: Resolution approving the Supplemental Annual Investment Program (AIP) No. 3 in the amount of Three Hundred Fifty Three Million Nine Hundred Sixty Six Thousand Four Hundred Forty Two Pesos and Sixty Eight Centavos (P353,966,442.68);
