## ORDINANCE NO. 009 Series of 2024

AN ORDINANCE APPROVING THE ABOLITION OF THREE (3) VACANT PERMANENT AND CASUAL POSITIONS AND THE CREATION OF TWO (2) PERMANENT POSITIONS UNDER THE PROVINCIAL HUMAN RESOURCE MANAGEMENT OFFICE (PHRMO)

**BE IT ENACTED**, by the Sangguniang Panlalawigan of the Province of Negros Occidental in its regular session duly assembled that:

SECTION 1. ABOLITION. Three (3) vacant permanent and casual positions are hereby abolished at the Provincial Human Resource Management Office (PHRMO) to wit:



SECTION 2. CREATION. Two (2) permanent positions are hereby created at the Provincial Human Resource Management Office (PHRMO), to wit:

Position	Salary Grade	Monthly Rate
Administrative Officer I (Records Officer I)	10	P23,176.00
Psychologist II	15	P36,619.00

**SECTION 3.** SOURCE OF FUND. – The funding requirements for the Personal Services (PS) cost of the proposed creation of positions shall be provided in the ensuing supplemental budget to be sourced from the PS appropriation of the abolished positions.

SECTION 4. SEPARABILITY CLAUSE. – If for any reason, any provision, section or part of this ordinance is declared not valid by a government agency or a court of competent jurisdiction, such judgment shall not affect the other sections or provisions of this ordinance, which shall continue to be in full force and effect.

**SECTION 4.** REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
