RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-02 OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 2 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FOUR MILLION PESOS (P4,000,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 2 of the Municipality of Hinoba-an, Negros Occidental, with a total appropriation of Four Million Pesos (P4,000,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 2024-02;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, CY 2016 Budget Operations Manual for Local Government Units, and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, to approve Appropriation Ordinance No. 2024-02 of the Municipality of Hinoba-an, Negros Occidental, subject to the following conditions and reminders:

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.


