**RESOLUTION NO. 0854**  
**Series of 2024**

**RESOLUTION DECLARING CITY ORDINANCE NO. 08, SERIES OF 2024 OF SILAY CITY, NEGROS, OCCIDENTAL, ENTITLED, "AN ORDINANCE ON THE INTEGRATION OF THE BARANGAY CLEARANCE TO THE BUSINESS PERMITTING PROCESS OF THE CITY OF SILAY AND AUTHORIZING THE CITY TREASURER, THROUGH THE BUSINESS LICENSE & PERMITS OFFICE (BPLO), TO ISSUE AND COLLECT THE CORRESPONDING FEES AS REFLECTED IN THE DIFFERENT BARANGAY TAX ORDINANCES, IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS, SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE SUBJECT BARANGAYS AND THE CONDITIONS HERETO ENUMERATED IN THIS ORDINANCE," AS A VALID ENACTED ORDINANCE**

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it's consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, City Ordinance No. 08, series of 2024 of the City of Silay on the integration of Barangay Clearance to the business permitting process in the City of Silay and authorizing the City Treasurer, through the Business License and Permits Office (BPLO) to issue and collect the corresponding fees as reflected in the different barangay tax ordinances, in the application for any business-related transactions, subject to the remittance of the aforesaid fees to the subject barangays and the conditions hereto enumerated in this ordinance, was submitted for review by the City of Silay to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of Silay to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the Sangguniang Panlungsod of Silay has the power to enact the subject ordinance, which is in keeping with Local Government Code of 1991 (R.A. 7160), to wit:

*"Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall × xx, among other things, × xx, preserve the comfort and convenience of their inhabitants."(Section 16, Local Government Code of 1991, RA 7160)*

*"Section 458. (a) The Sangguniang Bayan, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to section 16 of this Code and in the proper exercise of the corporate powers of the city as provided for under section 22 of this Code, and shall:*

*(3) Subject to the provisions of Book II of this Code, x x x, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances xxx upon such conditions and for  
(ii) Regulate any business xxx within the city and the conditions under which the license for said business xxx may be issued or revoked;*

**WHEREAS**, the subject ordinance also finds legal support under Republic Act No. 11032, to wit:

*"Sec. 11. Streamlined Procedures for the Issuance of Local Business Licenses, Clearances, Permits, Certifications or Authorizations. - The LGUs are mandated to implement the following revised guidelines in the issuance of business licenses, clearances, permits, certifications or authorizations:*

*"(f) Barangay clearances and permits related to doing business shall be applied, issued, and collected at the city/ municipality in accordance with the prescribed processing time of this Act: Provided, That the share in the collections shall be remitted to the respective barangays.*

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**NOW THEREFORE**, premises considered, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr. unanimously by the members present during the regular session of the Sangguniang Panlalawigan of Negros Occidental, resolved, as it hereby resolves, to pass and approve this resolution to wit:
