***RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2024-004 OF THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL, INTEGRATING BARANGAY CLEARANCE FOR PERMITS RELATED TO DOING BUSINESS APPLIED, ISSUED AND COLLECTED IN THE MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL AND AUTHORIZING THE REMITTANCE OF SUCH COLLECTIONS TO THE RESPECTIVE BARANGAYS, PURSUANT TO REPUBLIC ACT NO. 11032 ENTITLED "AN ACT OF PROMOTING EASE OF DOING BUSINESS AND EFFECTIVE DELIVERY OF GOVERNMENT SERVICES, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9485, OTHERWISE KNOWN AS THE ANTI-RED TAPE ACT OF 2007, AND FOR OTHER PURPOSES" AS A VALID ENACTED ORDINANCE***

***WHEREAS***, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Bayan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

***WHEREAS***, Municipal Ordinance No. 2024-004 of the Municipality of Ilog, Negros Occidental, entitled: *AN ORDINANCE INTEGRATING BARANGAY CLEARANCE FOR PERMITS RELATED TO DOING BUSINESS APPLIED, ISSUED AND COLLECTED IN THE*

*MUNICIPALITY OF ILOG, NEGROS OCCIDENTAL AND AUTHORIZING THE REMITTANCE OF SUCH COLLECTIONS TO THE RESPECTIVE BARANGAYS, PURSUANT TO REPUBLIC ACT NO. 11032 ENTITLED "AN ACT OF PROMOTING EASE OF DOING BUSINESS AND EFFECTIVE DELIVERY OF GOVERNMENT SERVICES, AMENDING FOR THE PURPOSE REPUBLIC ACT NO.9485, OTHERWISE KNOWN AS THE ANTI-RED TAPE ACT OF 2007, AND FOR OTHER PURPOSES"* was submitted for review by the Municipality of Ilog to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of Ilog enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, providing legal support in the enactment of the subject ordinance are Sections 16 and 447 (a) (3) (ii) of the Code, as well as, Republic Act No. 11032, Section 11 (f) thereof, hence:

*Section 16. Every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, xxx.*

*Section 447. Powers, Duties, Functions and Compensation. - (a) The sangguniang bayan, as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of this Code and in the proper exercise of the corporate powers of the municipality as provided for under Section 22 of this Code, and shall:*

*X x x*

*(3) Subject to the provisions of Book II of this Code, grant franchises, enact ordinances authorizing the issuance of permits or licenses, or enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the municipality, and pursuant to this legislative authority shall:*

*X x x*

*(ii) Regulate any business, occupation, or practice of profession or calling which does not require government examination within the municipality and the conditions under which the license for said business or practice of profession may be issued or revoked;*

*Section 11. Streamlined Procedures for the Issuance of Local Business Licenses, Clearances, Permits, Certifications or Authorizations. - The LGUs are mandated to implement the following revised guidelines in the issuance of business licenses, clearances, permits, certifications or authorizations:*

*"(f) Barangay clearances and permits related to doing business shall be applied, issued, and collected at the city/municipality in accordance with the prescribed processing time of this Act: Provided, That the share in the collections shall be remitted to the respective barangays.*
