**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-173 of the Municipality of Murcia adopting/approving the MDC Resolution No. 24-001, series of 2024 entitled: "Resolution approving the proposed PPAs in the amount of P11,649,765.58 to be funded from the Special Trust Fund of MDRRMC CY 2024";
