

RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, AS REPRESENTED BY NEGROS OCCIDENTAL LANGUAGE AND INFORMATION TECHNOLOGY CENTER (NOLITC), AND THE NEGROS WOMEN FOR TOMORROW FOUNDATION, INC. RELATIVE TO THE COLLABORATION OF BOTH PARTIES TO PROVIDE TRAININGS AND CARRY OUT RELATED PROGRAMS FOR THE MEMBERS OF THE SAID FOUNDATION UNDER THE SPONSORSHIP OF THE PROVINCE
