RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL, THE UNIVERSITY OF ST. LA SALLE, INC., AND THE DEPARTMENT OF EDUCATION RELATIVE TO THE PROJECT FREE SCHOLARSHIP GRANTS FOR QUALIFIED PUBLIC ELEMENTARY AND SECONDARY TEACHERS OF THE PROVINCE IN THE TOTAL AMOUNT OF TWENTY FOUR MILLION FIVE HUNDRED TEN THOUSAND THREE HUNDRED SIXTY EIGHT PESOS (P24,510,368.00)
