RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE OF NEGROS OCCIDENTAL THE DEED OF DONATION TO BE EXECUTED BY MS. DANICA MAE G. NAZARENO IN FAVOR OF THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE DONATION OF A PARCEL OF LAND CONTAINING AN AREA OF 13,109 SQUARE METERS, COVERED BY TCT NO. 091-2014002174, SITUATED AT BRGY. CABACUNGAN, LA CASTELLANA, NEGROS OCCIDENTAL.

WHEREAS, thereby presented for review and appropriate action of the Board is the request for the passage of a resolution authorizing the governor to sign, for and in behalf of the province, the Deed of Donation to be executed by Ms. Danica Mae G. Nazareno in favor of the Province of Negros Occidental relative to the donation of a parcel of land containing an area of 13,109 square meters situated at Brgy. Cabacungan, La Castellana, Philippines and covered by the Transfer Certificate Title No. 091-2014002174;

WHEREAS, Ms. Nazareno intends to donate the aforementioned parcel of land to the province to enhance the water supply in the Municipality of Moises Padilla;

WHEREAS, the subject Deed of Donation was drafted for the purpose of contributing to the greater good of the community of the Municipality of Moises Padilla, by offering the water

supply generated by the spring box which aims to address the insufficiency of the water supply, as initiated by the Former Mayor of the Municipality of Moises Padilla, Hon. Francisco M. Nazareno, and to promote local economic activity;

WHEREAS, the Instrument finds legal support in the Local Government Code of 1991, to wit:

Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, in view of the foregoing, the SP Committee on Laws, finding the documents to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., and duly seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Governor to sign, for and in behalf of the Province of Negros Occidental the Deed of Donation to be executed by Ms. Danica Mae G. Nazareno in favor of the Province of Negros Occidental relative to the donation of a parcel of land containing an area of 13,109 square meters situated at Brgy. Cabacungan, La Castellana, Philippines and covered by the Transfer Certificate Title No. 091-2014002174.
