**RESOLUTION AUTHORIZING THE GOVERNOR TO IMPLEMENT THE FIRST TRANCHE SALARY SCHEDULE EFFECTIVE AUGUST 2, 2024 PURSUANT TO EXECUTIVE ORDER NO. 64, DATED AUGUST 2, 2024 AND GUIDED BY THE RULES AND REGULATIONS UNDER LOCAL BUDGET CIRCULAR NO. 160, DATED AUGUST 12, 2024 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM)**

**WHEREAS**, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the request of the Governor for the passage of a resolution authorizing him to implement the First Tranche Salary Schedule effective August 2, 2024 pursuant to Executive Order No. 64, dated August 2, 2024 and guided by the Rules and Regulations under Local Budget Circular No. 160, dated August 12, 2024 of the Department of Budget and Management (DBM):

**WHEREAS**, the new salary rates shall be in accordance with the Salary Schedules for first Class Provinces provided under “Annex A-1” of LBC No. 160, dated August 12, 2024 of the DBM;

**WHEREAS**, the amounts needed for the salary adjustments shall be charged against the available Personal Services (PS) appropriations of each office/department or the Miscellaneous Personnel Benefit and augmentation of funds pursuant to Section 336 of RA 7160, otherwise known as the Local Government Code of 1991, and authorized under Section 11 of Appropriation Ordinance No. 2023-006, shall be made in case of deficiency in PS appropriation of various offices;

**WHEREAS**, the implementation of the salary increase is within the Personal Services (PS) limitation prescribed under Section 325(a) of RA 7160;
