**RESOLUTION DECLARING ORDINANCE NO. 27, SERIES OF 2024, OF THE MUNICIPALITY OF LA CASTELLANA ENTITLED: “LA CASTELLANA CLOSED-CIRCUIT TELEVISION (CCTV) INSTALLATION ORDINANCE AND FOR OTHER PURPOSES” AS A VALID ENACTED ORDINANCE**

**WHEREAS**, section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, Ordinance No. 27, series of 2024 of the Municipality of La Castellana, Negros Occidental, entitled: “La Castellana Closed-Circuit Television (CCTV) Installation Ordinance and for other purposes” was submitted for review by the Municipality of La Castellana to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Bayan of La Castellana to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the subject ordinance is grounded in Section 447 of R.A. 7160, which empowers the Sangguniang Bayan of La Castellana, as the legislative body of the municipality, to enact ordinances aimed at preventing and suppressing activities harmful to the welfare of its inhabitants and promoting the general welfare. In line with this mandate, the ordinance addresses specific concerns that impact public safety, health, and overall community well-being, ensuring that the municipality's legislative actions are focused on safeguarding and enhancing the quality of life for its residents.

**WHEREAS**, the reviewing authority of the Sangguniang Panlalawigan finds no irregularity that follow thereto as a result of the thorough scrutiny of the Provincial Legal Officer;

**WHEREAS**, in view of the foregoing, the Committee on Laws, recommends approval of the same;

**NOW THEREFORE**, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., and unanimously seconded by all the members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve this resolution to wit:
