**RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF PARK HOMES FARM WORKERS ASSOCIATION (PAHOFAWA) IN THE PROVINCE OF NEGROS OCCIDENTAL**

**WHEREAS**, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

**WHEREAS**, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;

**WHEREAS**, Park Homes Farm Workers Association (PAHOFAWA) with office address at Sitio Buntoranon, Barangay Washington, Escalante City, Negros Occidental, through its Chairman, Sandy J.
