

RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF BRGY. OLD SAGAY DRIED AND FRESH FISH VENDORS ASSOCIATION (BOSDAFFVA) IN THE PROVINCE OF NEGROS OCCIDENTAL

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives to the Local Special Bodies;
