RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR TO SIGN, FOR AND ON BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF BARANGAY SITIO SO-OL FARM WORKERS ASSOCIATION RELATIVE TO THE DONATION OF ONE (1) UNIT WEIGHING SCALE 10 KILOS IN THE AMOUNT OF ONE THOUSAND FOUR HUNDRED SEVENTY FIVE PESOS (P1,475.00)

WHEREAS, the request of Gov. Eugenio Jose “Bong” V. Lacson, dated August 5, 2024, has been forwarded to the Sangguniang Panlalawigan relative to the Deed of Donation between the Province of Negros Occidental and Barangay Sitio So-ol Farm Workers Association;

WHEREAS, the attached Deed of Donation of the Province of Negros Occidental seeks to donate one (1) unit Weighing Scale 10 kilos in the amount of One Thousand Four Hundred Seventy Five Pesos (P1,475.00);

WHEREAS, the instrument finds legal support in the Local Government Code of 1991, to wit:

Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the

preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, in view of the foregoing, the SP Committee on Laws recommends approval of the same;


NOW THEREFORE, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to grant an authority to Provincial Governor to sign, for and on behalf of the province, the Deed of Donation to be executed by the Province of Negros Occidental in favor of **Barangay Sitio So-ol Farm Workers Association** relative to the donation of one (1) unit Weighing Scale 10 kilos in the amount of One Thousand Four Hundred Seventy Five Pesos (P1,475.00).
