1. *The utilization of the 20% Development Fund shall be in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DoF and DILG dated November 4, 2020, and consistent with the approved Annual Investment Program (AIP).*

WHEREAS in view of the foregoing, the SP Committee on Finance recommends approval of the same;

RESOLVED FINALLY, compliance with existing laws rules and regulations shall be the responsibility of the Municipality.


