RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-002 OF THE CITY OF KABANKALAN, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2024 OF THE CITY OF KABANKALAN FROM GOVERNMENT EQUITY SURPLUS (2023 SURPLUS) IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR THE FOOD SECURITY PROGRAM OF THE CITY AGRICULTURE OFFICE”

WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 2024-002 of the City of Kabankalan, Negros Occidental entitled: “AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2024 OF THE CITY OF KABANKALAN FROM GOVERNMENT EQUITY SURPLUS (2023 SURPLUS) IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR THE FOOD SECURITY PROGRAM OF THE CITY AGRICULTURE OFFICE”;

WHEREAS, the same shows substantial compliance with the same law, its implementing Rules and Regulations, with Budget Operations Manual from Local Government Units, 2023 Edition and with implementing circulars and other issuances.

the Sangguniang Panlalawigan – (a) within three (3) days after approval, the secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils.

WHEREAS in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-002 of the City of Kabankalan, Negros Occidental entitled: “AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 2 FOR FISCAL YEAR 2024 OF THE CITY OF KABANKALAN FROM GOVERNMENT EQUITY SURPLUS (2023 SURPLUS) IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR THE FOOD SECURITY PROGRAM OF THE CITY AGRICULTURE OFFICE”;


