THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY
AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CENTRAL
PHILIPPINE ADVENTIST COLLEGE (CPAC) RELATIVE TO THE IMPLEMENTATION
OF THE “AGRI-ABANSE EDUCATIONAL ASSISTANCE TO FARM YOUTH”
PROGRAM WHICH WILL GRANT FINANCIAL/EDUCATIONAL ASSISTANCE TO THE
GRANTEES OF THE SAID PROGRAM CHARGEABLE AGAINST THE 2024 GAD FUND***

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the Central Philippine Adventist College (CPAC) relative to the implementation of the “Agri-Abanse Educational Assistance to Farm Youth” Program which will grant financial/educational assistance to the grantees of the said program chargeable against the 2024 GAD Fund;

WHEREAS, the Province of Negros Occidental in its concern and sustained efforts to increase the attractiveness of agriculture education, implemented the educational support program to provide educational opportunity to farm youth and children of smallholder farmers and fisherfolk;

WHEREAS, the educational assistance herein referred as the “Agri-Abanse Educational Assistance to Farm Youth” initiated by the Province is a strategic mechanism to attract and engage the young farmers and youth to take agriculture as their profession thereby contributing to the goals of food security and alleviation of the socio-economic status of families in the agriculture and fisheries sector;
