RESOLUTION NO. 1415 Series of 2024

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE ILOILO PARAMOUNT INDUSTRIAL AND ELECTRICAL CO., INC. AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE DONATION OF TWO (2) BOXES OF SOLAR STREET LIGHTS TO THE PROVINCE FOR THE USE OF SITIO TAMBARA, BARANGAY SAN FERNANDO, TALISAY CITY, NEGROS OCCIDENTAL

WHEREAS, the request from Gov. Eugenio Jose "Bong" Lacson, dated November 26, 2024, has been forwarded to the Sangguniang Panlalawigan concerning the Deed of Donation between the Province of Negros Occidental and the Iloilo Paramount Industrial and Electrical Co. Inc.;

WHEREAS, the Iloilo Paramount Industrial and Electrical Co. Inc. seeks to donate to the Province of Negros Occidental two (2) boxes of Solar Street lights;

WHEREAS, the document is aligned with the R.A. 7160 otherwise of the Local Government Code especially under the General Welfare Clause, to wit:

Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.
