RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE BRGY. SU-AY BIRTHING FACILITY AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE REFERRAL OF PATIENTS OF THE SAID FACILITY FOR X-RAY AND LABORATORY EXAMINATIONS COVERED BY PHILHEALTH TO THE GOV. VALERIANO M. GATUSLAO MEMORIAL HOSPITAL

WHEREAS, thereby presented to the Board for review and appropriate action is the request for authority to the Provincial Governor to sign the Memorandum of Agreement to be entered into by and between the Brgy. Su-ay Birthing Facility and the Province of Negros Occidental relative to the referral of patients of the said facility for x-ray and laboratory examinations covered by Philhealth to the Gov. Valeriano M. Gatuslao Memorial Hospital;

WHEREAS, said agreement finds legal basis in Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, which empowers local government units, in the exercise of its powers essential to the promotion of the general welfare, to promote health and safety;

WHEREAS, as stated in the agreement, the provision of the services shall take effect upon signing of both parties to and for the duration of one (1) year which may be renewed upon mutual consent of the parties;
