RESOLUTION NO. 1430 Series of 2024

RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE MUNICIPALITY OF PONTEVEDRA AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE REFERRAL OF PATIENTS IN THE RURAL HEALTH UNIT OF THE SAID MUNICIPALITY NEEDING AMBULANCE SERVICES AND LABORATORY DIAGNOSTIC SERVICES TO THE VALLADOLID DISTRICT HOSPITAL AND DON SALVADOR BENEDICTO DISTRICT HOSPITAL

WHEREAS, thereby presented to the Board for review and appropriate action is the request for authority to the Provincial Governor to sign, for and in behalf of the Province, the Memorandum of Agreement to be entered into by and between the Municipality of Pontevedra and the Province of Negros Occidental relative to the referral of patients in the Rural Health Unit of the said municipality needing ambulance services and laboratory diagnostic services to the Valladolid District Hospital and Don Salvador Benedicto District Hospital;

WHEREAS, said agreement finds legal basis in Section 16 of RA 7160, otherwise known as the Local Government Code of 1991, which empowers local government units, in the exercise of its powers essential to the promotion of the general welfare, to promote health and safety;

WHEREAS, as stated in the agreement, the provision of the services shall take effect upon signing of both parties and shall continue until and unless terminated by either party;
