MIRANDA AND THE PROVINCE OF NEGROS OCCIDENTAL RELATIVE TO THE SALE OF AN 11,000 SQUARE METER PROPERTY UNDER TCT NO. T-112721, LOT NO. 70-A PT. OF 683, LOCATED AT BRGY. SAN ISIDRO, E.B. MAGALONA, NEGROS OCCIDENTAL TO BE UTILIZED FOR THE NEGROS OCCIDENTAL BULK WATER SUPPLY PROJECT IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED ONE THOUSAND FIVE HUNDRED SIXTY FIVE PESOS (P1,801,565.00)


