**RESOLUTION APPROVING AND CONCURRING WITH RESOLUTION NO. 2024-09 OF THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) OF THE PROVINCE OF NEGROS OCCIDENTAL, APPROVING AND AUTHORIZING THE GOVERNOR TO RELEASE AND USE THE CONFIDENTIAL FUND FOR THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL FOR CY 2025 IN THE AMOUNT TO TWENTY FIVE MILLION EIGHT HUNDRED SEVENTY TWO THOUSAND PESOS (P25,872,000.00)**

**WHEREAS**, Section 106 of RA 7160, otherwise known as the Local Government Code of 1991 provides that “each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development councils and approved by its sanggunian”;

**WHEREAS**, Section 114 of the said code further provides that the plans, programs and projects proposed by the local development council shall be submitted to the sanggunian concerned for appropriate action;

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-09 of the Provincial Peace and Order Council (PPOC) of the Province of Negros Occidental, approving and authorizing the Governor to release and use the Confidential Fund for the Provincial Government of Negros Occidental for CY 2025 in the amount to Twenty Five Million Eight Hundred Seventy Two Thousand Pesos (P25,872,000.00);

**WHEREAS**, finding the same to be in order, the SP Committee on Peace & Order recommends for the approval and concurrence of the same;
